

# NAHU Blue Chip/Regional Award

## Criteria and Documentation Suggestions

### I. NAHU Events

1. Credentialed delegates at National Convention: Verified by NAHU Staff
2. Additional registered attendees at National Convention: Verified by NAHU Staff
3. State Legislative Chairs attending Capitol Conference: Verified by NAHU Staff
4. Additional registered attendees at Capitol Conference: Verified by NAHU staff
5. State and Local Membership or Retention Chairs at Annual Convention: Verified by NAHU staff. Note: credit will be given for either the Membership Chairs or the Retention Chairs attendance.
6. Regional Membership and Retention Chairs at Annual Convention: Verified by NAHU Staff. Note: credit will be given for Membership Chairs attendance and, for Retention Chairs attendance, if each job is filled by a unique person. If the same person serves as both chairs, the credit will be given only once.
7. President or President-elect attend the NAHU Leadership Forum at Capitol Conference: Verified by NAHU staff
8. Regional Chapter Development Chair attend the NAHU Leadership Forum at Capitol Conference: Verified by NAHU staff

**Officer numbers are based on the number of chapters with these officers appointed.**

### II. Regional Management

1. Holding a regularly scheduled call with state president and regional leadership: Documentation should include attendance rosters
2. RVP attendance at State Symposiums: Documentation could include thank you note from State, Agenda, State Board minutes indicating attendance.
3. RVP attendance at State or Local Strategic Planning Meetings: Documentation should include minutes from the Strategic Planning meeting showing attendance, or a thank you letter from the State or Local recognizing attendance
4. Hosted a Regional Meeting: Documentation should include invitations sent to the Region, meeting agenda, and copy of RVP report to BOT showing the meeting took place.
5. Additional Core Curriculum: Includes the following: Media module, "NAHU Website Overview" module, Membership/Retention training, Legislative Leadership and HUPAC training, AWARDS/LPRT training, Professional Development training. Core curriculum should be used during the meeting, in a format best suited to attendees and presenter(s).
6. Promoting the core curriculum to state and local chapters. Documentation should include meeting notes where chapters are encouraged to present the leadership training to their officers. If the event is hosted by the RVP, invites and notes should be included.
7. Registered attendees at Regional meeting: If the list have been submitted to NAHU they will be Verified by NAHU staff
8. State and Local Membership or Retention Chairs at Regional Meeting: Verified by NAHU staff. Note: Credit will be given for either the Membership Chair or the Retention Chair attendance.
9. State and Local Retention Chairs Chapter Presidents at Regional Meeting: Verified by NAHU

1. Percentage of growth in membership: Effective period of April 1 to March 31; Verified by NAHU Staff
2. Retention of Membership: Effective period of April 1 to March 31; Verified by NAHU Staff
3. Membership support of HUPAC: Effective period of January 1 to December 31; Verified by NAHU Staff. Basis for above percentage will be the December membership report from the previous calendar year.
4. Increase (%) in HUPAC Contributions: Effective period of January 1 to December 31; Verified by NAHU Staff. Basis for above percentage will be the December membership report from the previous calendar year.
5. Number of new Triple Crown Award recipients: Verified by NAHU Staff
6. Number of renewing Triple Crown Award recipients: Verified by NAHU Staff
